



# Pues and Laws

When you go to school every day, you are expected to follow a set of rules the school has created. Rules are guidelines for a happy, healthy and safe environment for you to be in while you are at school.

Other names for rules can include; requirements, directions, or commands. They would have been developed and changed over time as members of the school community experience challenges in day to day activity and growth - this includes growth in ideas, as well as size!

Rules are set by individuals for the benefit of a particular group or organisation.

Whilst a set of rules is usually made for a particular group of people, such as a school; a law can cover a whole community, and the consequences for breaking a law can range from a warning to a more serious punishment, such as a custodial sentence - time in goal. The consequence will be determined by the **severity** of the offence.

### Who enforces the law?

The police enforce the law in a society. There are two levels of policing in Australia, the state level and the federal level. The State Police enforce and protect citizens within each state, and each state has their own police force organisation to manage.

The Federal Police protect citizens across all of Australia in a broad range of matters. However, both groups often work together to share information and support each other in maintaining the law of the land.





# how laws are made

Laws are created by a society's governing authority at state and federal level. They are made for keeping order in society.

To make a new law, it must be voted on in government and passed as a majority. That means everyone is required to agree on what the law will be and what consequences will occur if the new law is broken. Laws are not flexible, once a law is approved it cannot be easily changed (amended), unlike a rule that can frequently change according to circumstances.

Any changes to a law must go through the whole process of a majority vote again.

Once a law is passed, it is then applied to everyone within the society for which it was made, including the law makers! This concept is called the 'rule of law' and it means that no-one is above the law.
