

RULE OF LAW IN ISRAEL

COMPARISON WITH AUSTRALIA

This resource compares the health of the rule of law in Israel and in Australia by using an indicator provided by Global Economy.Com.

The organisation has compiled country-specific data from 2000-2021, both ranking each country globally as well as individually using a point system. Unless otherwise indicated, a point score closer to -2.5 is weak, whereas a point score of 2.5 is strong. A global rank of 1/192 is more favourable than a rank of 192/192.

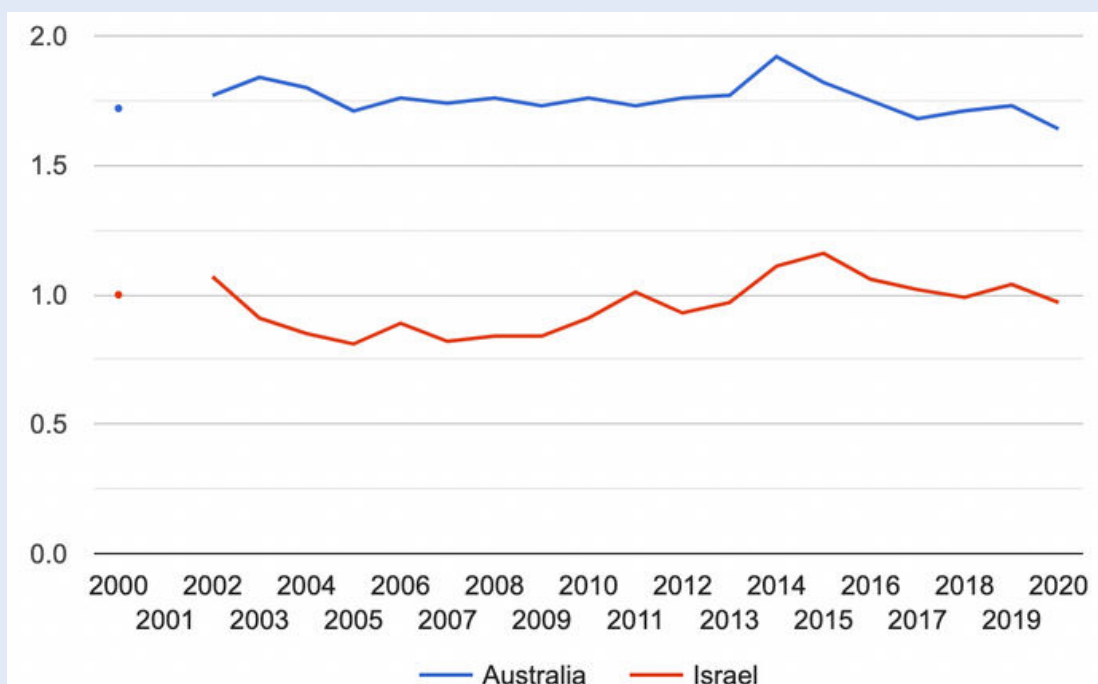

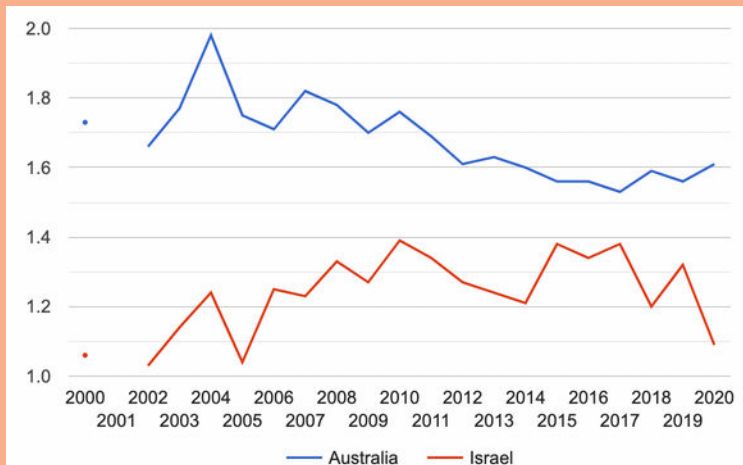

INDEX: Control of Corruption

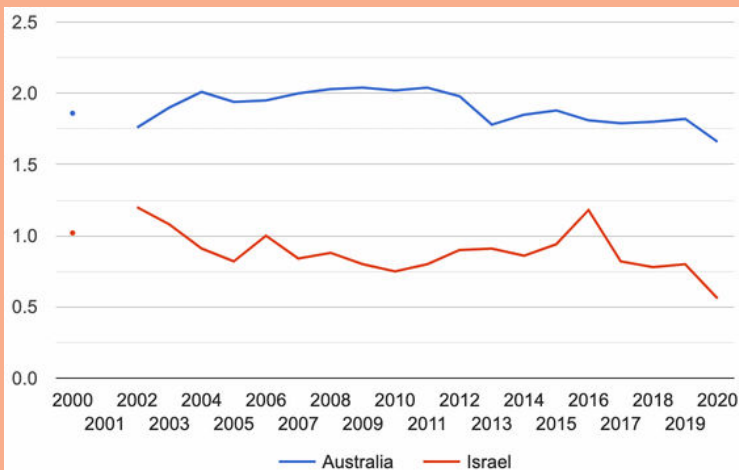

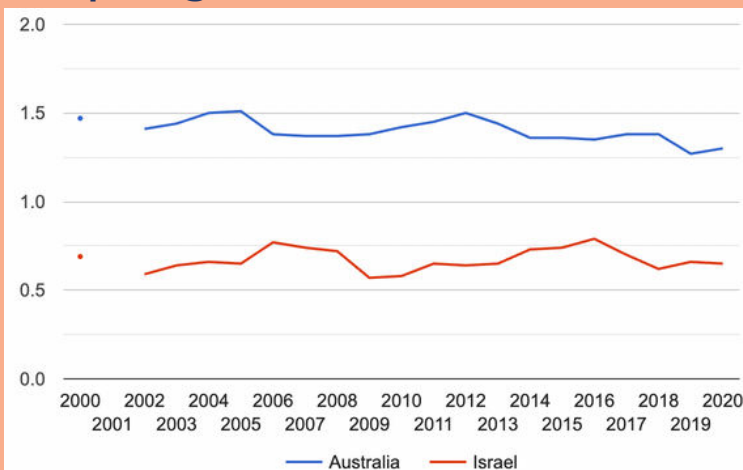

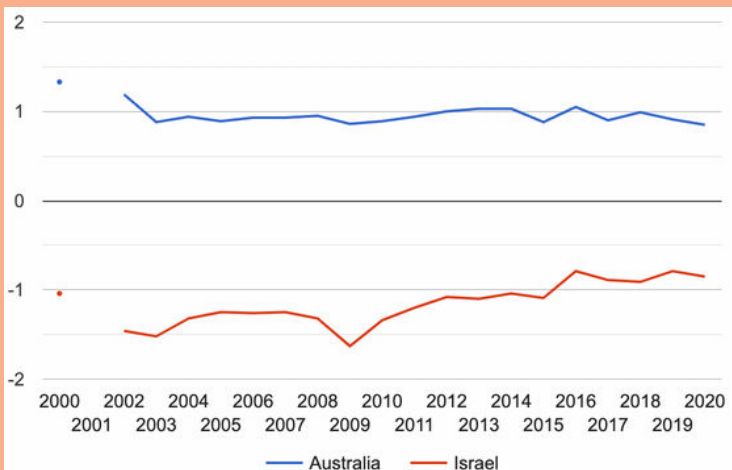

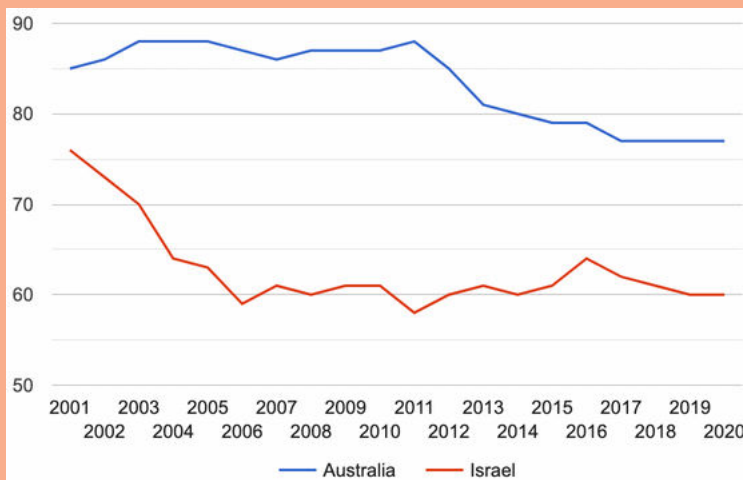

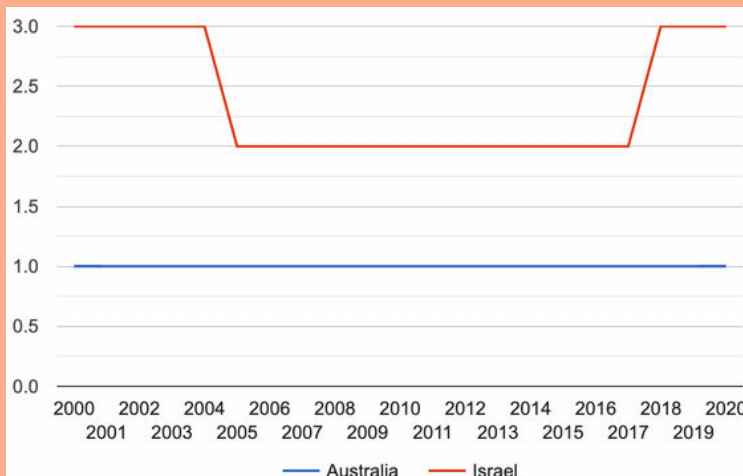

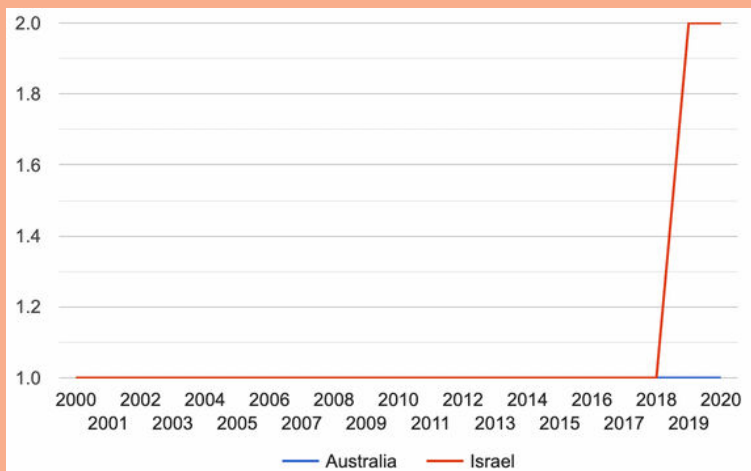
